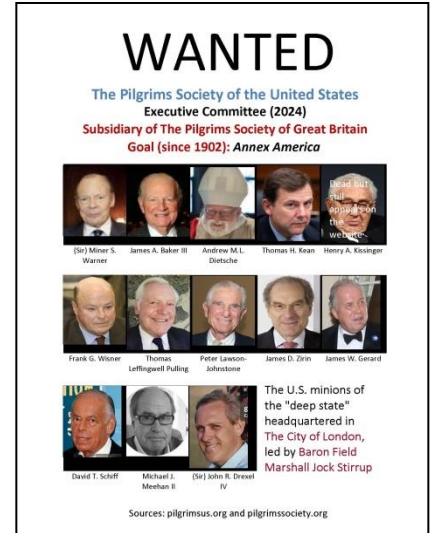
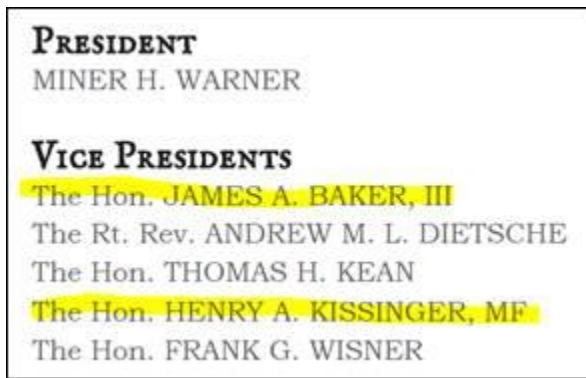


WANTED: The Executive Committee of the U.S. Pilgrims Society

The interlocked Anglo-American corruption of the **U.S. Pilgrims Society EXECUTIVE COMMITTEE:**

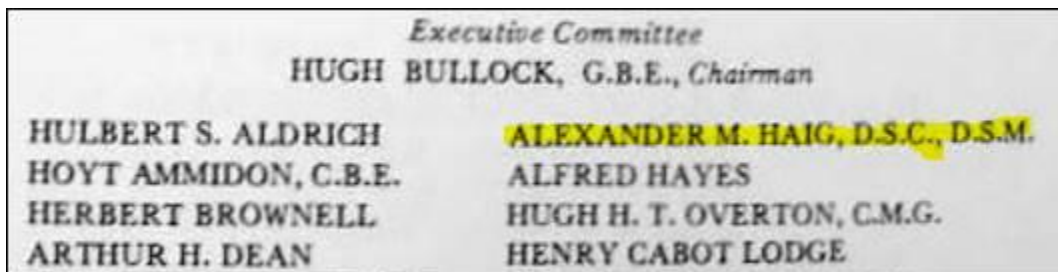
James A. Baker III was “New World Order” Bush’s Right Hand Man and **Henry A. Kissinger’s** understudy, as was **Alexander M. Haig**.
