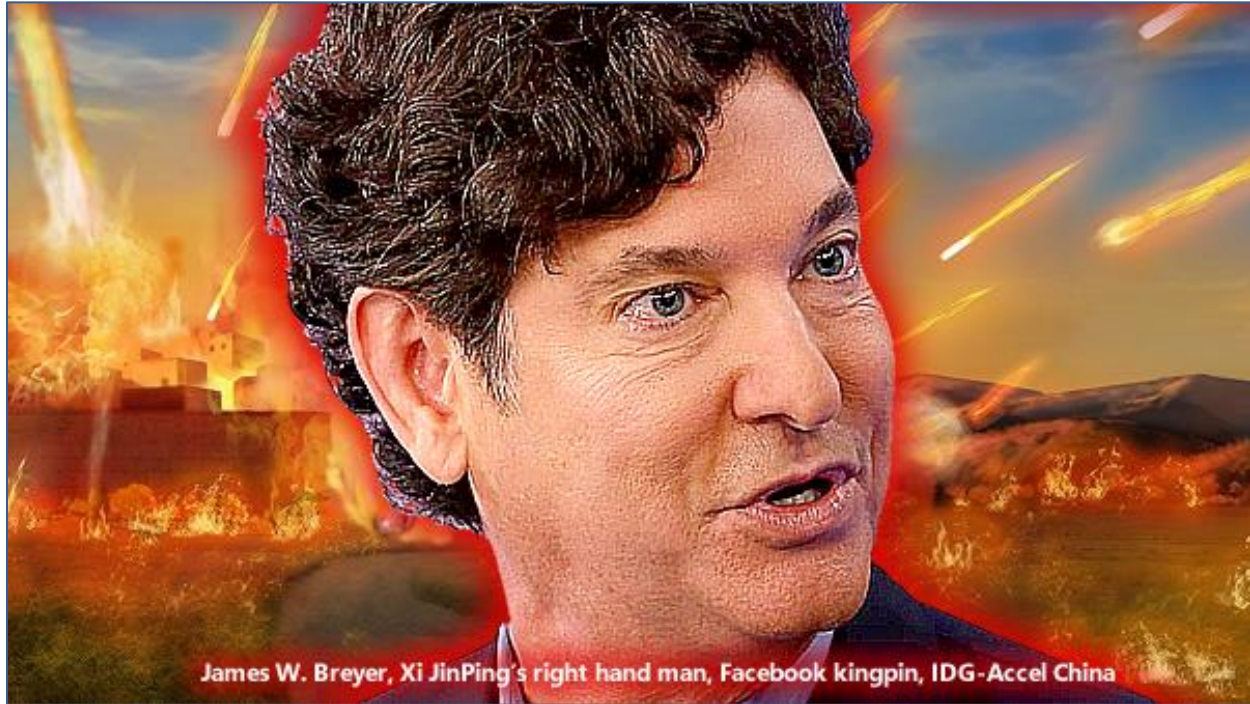


# Exposé: James W. Breyer and the Pilgrims Society's Scheme to Subjugate America

Privy Counsellor Cecil Rhodes, Viscount Alfred Milner, Baron Lionel Walter Rothschild, Baron Rosebery (Rothschild by inheritance), Baron Henry De Worms (Lord Pirbright, maternal Rothschild), W.T. Stead (father of tabloid journalism), Viscount Burnham, Viscount Northcliffe, MP Philip Whitwell Wilson (Vladimir Lenin, YMCA handler), Joseph Choate, Oxford University, Cambridge University, Nicholas Murray Butler (Columbia University), Elihu Root, J.P. Morgan, (Sir) Andrew Carnegie, John D. Rockefeller, King Edward VII, and Sir Winston Churchill. These political and banking aristocrats aimed to unify British and American elitists to dominate global affairs, with Rothschild's role in the 1917 Balfour Declaration—securing British control over Palestinian assets—exemplifying their strategic vision *Pilgrims Society*.

Historical records reveal the Society's insidious influence, from orchestrating economic crises to supporting ideological movements that destabilize nations for profit. World War I was their first foray into global hegemony. In the 1920s, through figures like Philip

Whitwell Wilson, the Society backed the Institute of Pacific Relations (IPR), funneling propaganda to bolster Chinese communism, creating a British-Chinese interlock that opened vast markets to exploitation. Wilson's 1925 article, "One Hundred Percent Chinese," was a masterstroke of manipulation, sowing seeds of revolution that reshaped Asia *British War on Christianity*. This strategy of controlled chaos, documented in the McCarran Committee's 1952 findings, is the blueprint Breyer follows today, redirecting American technology to serve the same globalist ends.

The Society's power lies in its ability to infiltrate governments, corporations, media, and technology, controlling *Reuters* and Fleet Street in London and *New York Times* and Madison Avenue in New York with unmatched propaganda. Its members, bound by a secret oath to British interests, operate as a shadow government, their influence felt in every major geopolitical shift. A 1940 congressional document by Hon. J. Thorkelson exposed the Society's efforts to foster Anglophile loyalty in the U.S., undermining sovereignty through elitist networks and propaganda *1940 Congressional Document*.

Breyer's association with the American Academy of Achievement, where he received the Golden Plate Award in 2014, places him in direct contact with Pilgrims Society luminaries like Baron Jacob Rothschild, a member of the Academy's Awards Council and great-nephew of co-founder Baron Lionel Walter Rothschild, and (Sir) Henry Kissinger, a vice president of the Society from at least 2002 until his death in 2023, forging an interlocking relationship that amplifies his role as a Society operative.

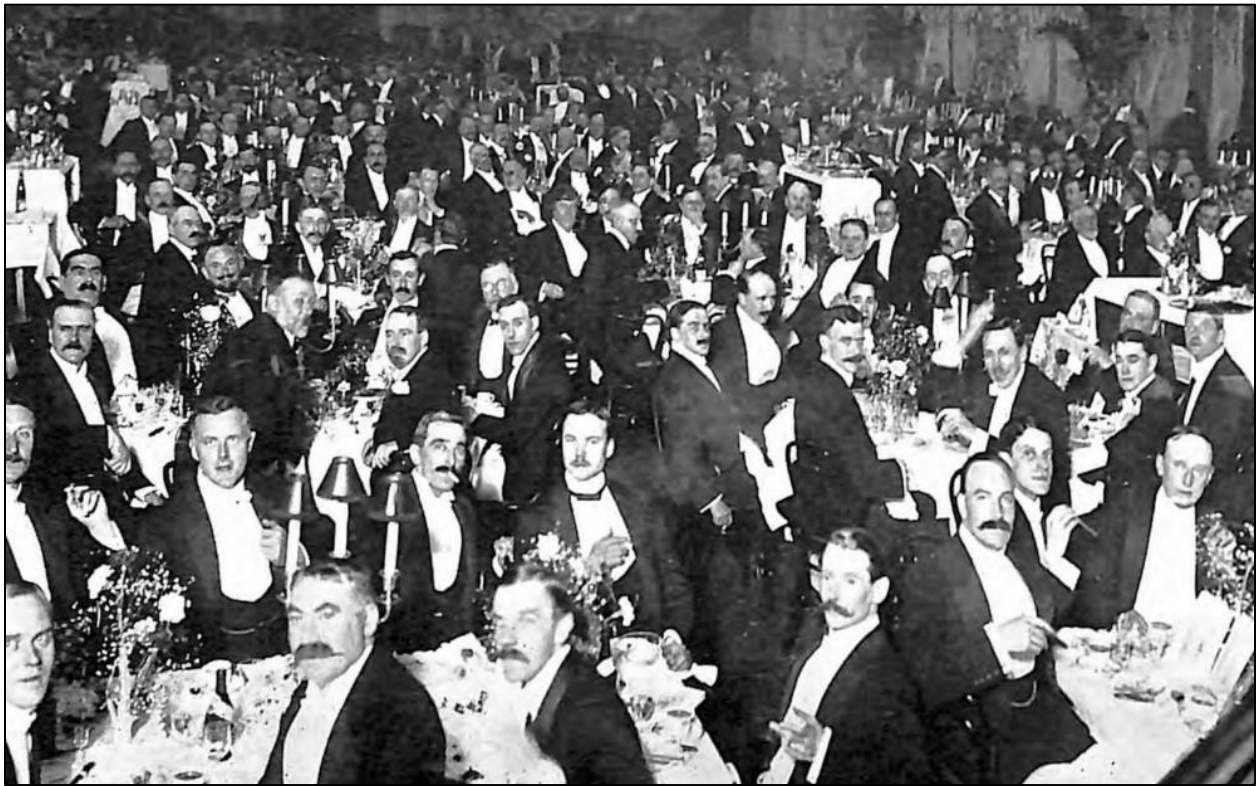

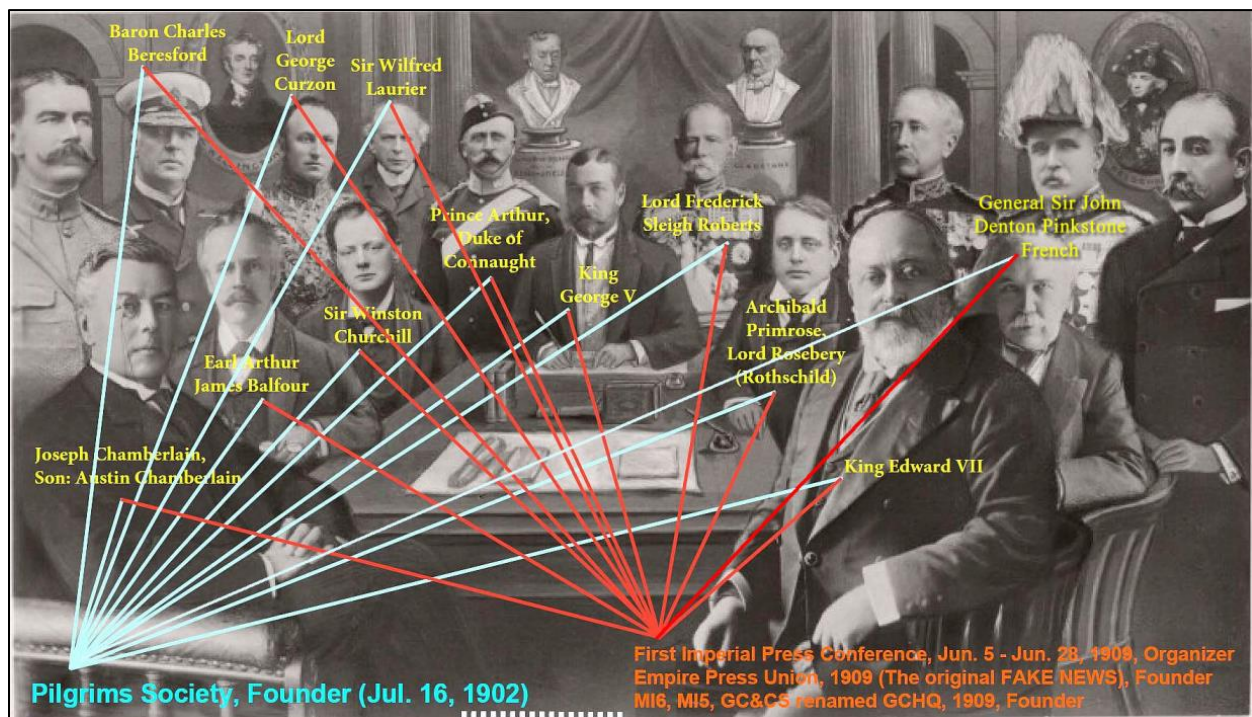

## The City of London: The Financial Citadel of Control



The City of London, a mere square mile within Greater London, is the beating heart of the Pilgrims Society's global empire *City of London*. Known as the "Square Mile," it houses the Bank of England, the London Stock Exchange, and a web of banks like HSBC and Rothschild & Co. that control trillions in global wealth. Governed by the City of London Corporation, an ancient entity with powers beyond those of ordinary governments, "The City" operates as a sovereign enclave, a state within a state where elitists dictate the rules.

At Stanford, Breyer's interdisciplinary studies and year in Florence, Italy, broadened his global perspective, grooming him for the Society's international agenda. His MBA from Harvard Business School polished his credentials, preparing him for elitist circles. Early roles at McKinsey & Company and Apple Computer gave him insider knowledge, but his 1987 entry into Accel Partners marked his initiation into the Society's ranks.

Under the guidance of Arthur Patterson and Jim Swartz, Jim Breyer ascended to managing partner at Accel Partners by 1995, shaping Silicon Valley's startup landscape. As NVCA chairman in 2004, he built connections with Gilman Louie and In-Q-Tel, the CIA's venture capital arm, linking U.S. tech to intelligence interests. His 2005 "bullish on China" speech signaled a shift toward offshoring American innovation, as noted in [Forbes](#) (behind a paywall). Shortly after, Accel's \$12.7 million investment in Facebook, allegedly built on stolen technology, solidified Breyer's influence as a tech powerbroker.

Through Breyer Capital, launched in 2006, he backed over 40 companies in AI, healthcare, and blockchain—sectors vital to a technocratic global agenda. Michael McKibben argues, "Jim Breyer isn't just a venture capitalist; he's a central figure in the Pilgrims Society's push to subordinate American innovation to a British-led global order, a plan rooted in the

League of Nations, refined through the United Nations, and fueled by conflicts from World Wars I and II to Korea, Vietnam, Cambodia, Kosovo, Rwanda, and the wars of the Bushes, the Clintons, Obamas, and Bidens. The Pilgrims thrive on perpetual conflict.”

## **The Great Heist: Robbing Leader Technologies' Innovation**

At the center of Breyer's actions is the theft of Leader Technologies' social networking invention—an act that led directly to the creation of Facebook and handed the Pilgrims Society a powerful tool for global control. Leader Technologies, founded by Michael McKibben in Columbus, Ohio, developed a revolutionary platform for scalable digital collaboration, formalized in U.S. Patent No. 7,139,761 in 2006 and other related patents.

On October 26, 2005, Breyer's firm, Accel Partners, Jim Swartz and Ping Li, met with Leader Technologies under a nondisclosure agreement, supposedly to discuss investment, which is what entrepreneurs and venture capitalists do. It's a dance where entrepreneurs share without disclosing the secret sauce and the venture capitalists cajole the entrepreneur to share the secrets.

During that meeting, McKibben got strange vibes from the two unfriendly Accel Partners inquisitors, so McKibben played his cards close to his chest. Something was wrong. They were too smug and dismissive, while simultaneously wanting to know more. Mike left the meeting having danced around the secret sauce to avoid any real disclosure. Little did he know that that Facebook already had his code secretly from his patent attorney James P. Chandler and his Washington, D.C. conspirator the IBM Eclipse Foundation.

Accel Partners withheld from Michael McKibben that they had already invested \$12.7 million in Facebook months earlier, securing a 15% stake and valuing the company at \$87.5 million. They also failed to disclose that Jim Breyer and Mark Zuckerberg were engaging Stanford students to develop apps for McKibben's stolen technology, which Zuckerberg later claimed in a separate case he built in under two weeks while preparing for Harvard finals. Breyer joined Facebook's board of directors, a role he held until 2013, guiding its growth and strategy while Zuckerberg served as the public figurehead—a front for Breyer's broader objectives. The timing was deliberate: Facebook's platform closely replicated Leader Technologies' invention, which had taken 175,000 man-hours and elite expertise to create with its advanced capabilities.

In late 2008, Leader Technologies filed a patent infringement lawsuit against Facebook, claiming the social media giant had used their technology without permission. The 2010 trial confirmed Facebook's infringement on 11 of 11 claims, a damning verdict that exposed Breyer's role in the theft. Yet, in a shocking twist, the Obama magistrate judge, Leonard P. Stark, ruled Leader's patent invalid due to an on-sale bar issue, a decision upheld on appeal despite evidence of judicial conflicts tied to Pilgrims Society influence. McKibben reflects, "Our court battle against Facebook exposed a corrupt judicial system, influenced by the same global elitists who back Breyer and his Pilgrims Society allies." Breyer's boardroom presence ensured Facebook became a surveillance juggernaut, collecting data on billions to serve the Society's control agenda, with Zuckerberg as the compliant front man, we believe.

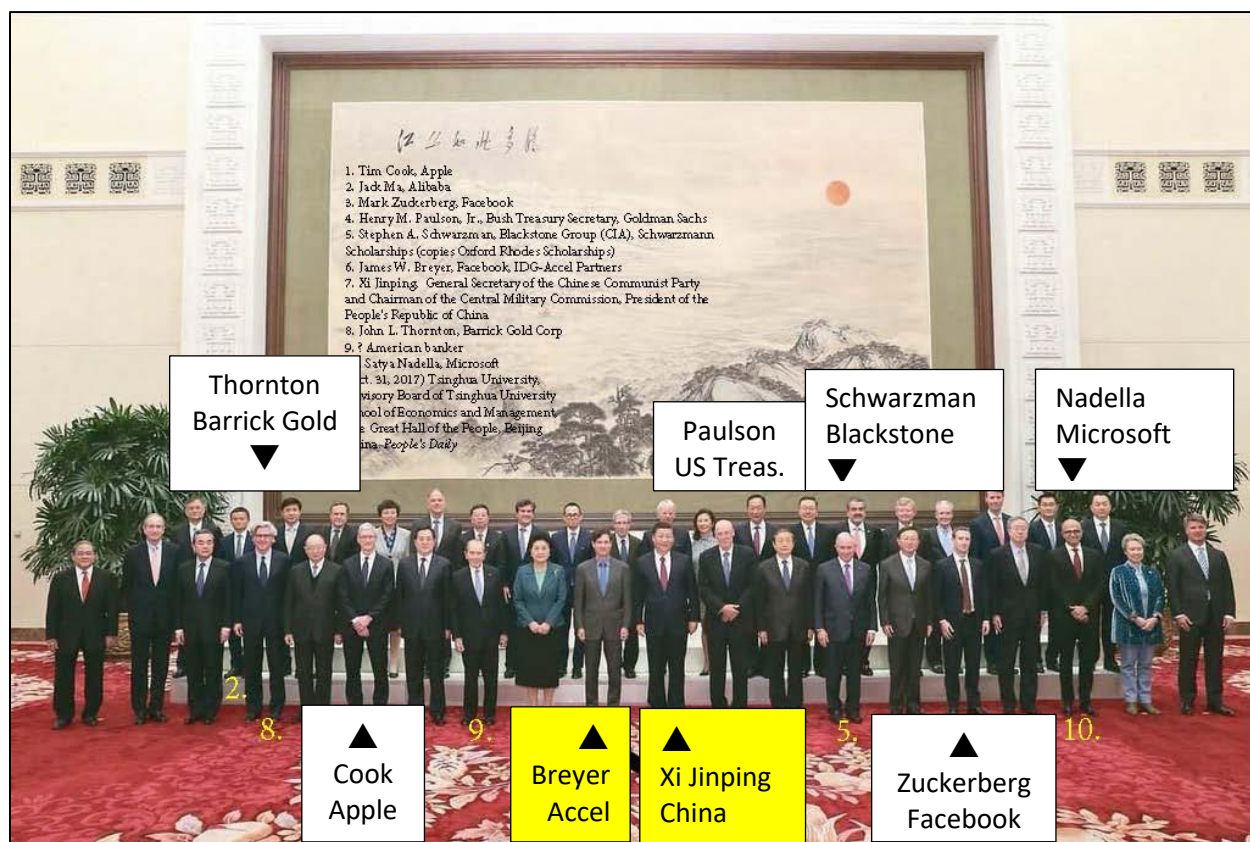
## China's Puppet: Breyer and Xi Jinping

Breyer's connections to China echo the Pilgrims Society's historical British-Chinese interlock, exemplified by the Institute of Public Relations (IPR)'s role in the 1920s. Through his partnership with IDG Capital, Breyer has invested billions in Chinese tech giants like Baidu, Tencent, Didi Chuxing, and Xiaomi since 2005 *Forbes: China Investments*. The Accel-IDG venture raised \$1 billion for IDG Capital Fund III in 2016, bolstering China's tech dominance. His advisory role at Tsinghua University places him among Beijing's elite, shaping China's economic future.

On October 31, 2017, Breyer led a delegation of U.S. self-anointed tycoons, including Mark Zuckerberg and Tim Cook, to meet Xi Jinping at Tsinghua University, a meeting broadcast by Chinese state media *The Diplomat: Xi Meeting*. This was a surrender, aligning U.S. tech with Chinese communism under Pilgrims oversight. Breyer's WininChina, Inc., formed in 2006 via HSBC in Hong Kong, hid his financial ties until exposed by the HSBC Swiss Leaks, revealing his role as a traitor.

## Angela Chao's Mysterious Death

In February 2024, Angela Chao, Breyer's wife and CEO of Foremost Group, died under suspicious circumstances, drowning in a pond on their Texas ranch after her Tesla vehicle plunged into the water *NY Times: Chao Death*. Chao, sister to Elaine Chao (Senator Mitch McConnell's spouse and former Transportation Secretary) and also connected to Chinese shipping oligarchs, was a key link in Breyer's network. The timing, amid scrutiny of Breyer's activities, fuels speculation of foul play to silence a potential whistleblower, underscoring the deadly stakes of his game.
